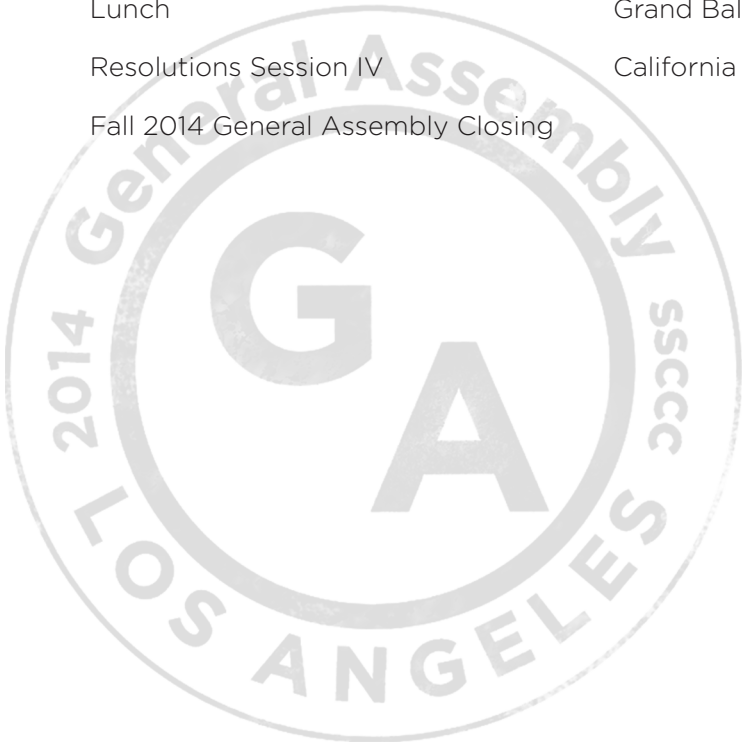

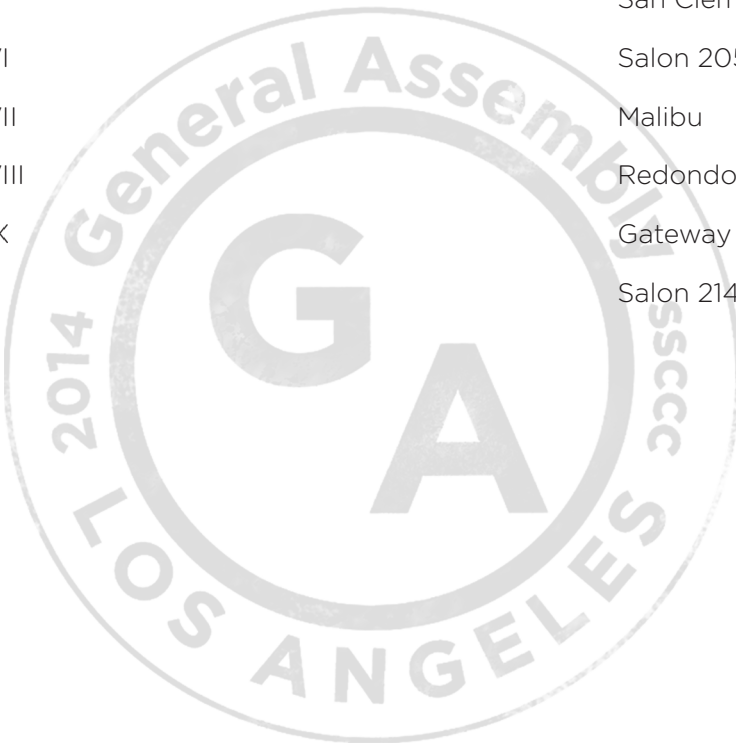

## Parliamentary Procedure Cheat Sheet:

### MOVE THE PREVIOUS QUESTION

Cannot interrupt the floor; must be seconded; non-debatable; requires 2/3

Effect: Closes debate on an item and moved immediately to a vote

State: "I MOVE THE PREVIOUS QUESTION."

### REQUEST FOR INFORMATION

Cannot interrupt the floor; must be a question; non-debatable

Effect: Request from the chair or representative information pertaining to the motion on the floor

State: "REQUEST FOR INFORMATION..."

### POINT OF ORDER

Cannot interrupt the floor; chair must rule on the issue

Effect: Recognizes a violation of parliamentary procedure

State: "POINT OF ORDER..."

### POINT OF PERSONAL PRIVILEGE

Cannot interrupt the floor; chair must rule on the issue

Effect: Recognizes a violation of a member's privilege as part of the body

State: "POINT OF PERSONAL PRIVILEGE..."

### MOVE TO EXTEND TIME

Cannot interrupt the floor; must be seconded; non-debatable; requires 2/3

Effect: Extends the time for debate on an item

State: "I MOVE TO EXTEND TIME FOR..."

### DIVISION

Can interrupt the floor

Effect: Divides the house to identify those in favor and those opposed

State: "DIVISION!"

### DIVIDE THE RESOLVES

Cannot interrupt the floor; must be seconded; debatable; majority

Effect: Divides "Resolved"s should they be able to stand alone to be discussed separately

State: "I MOVE TO DIVIDE THE RESOLVES..."

### REFER

Cannot interrupt the floor; must be seconded; debatable; majority

Effect: Refers an item to a body for discussion, possible action and report

State: "I MOVE TO REFER THE ITEM TO..."

### OBJECT TO THE CONSIDERATION

Can interrupt the floor; must occur before debate begins on the item; must be seconded, requires 2/3

Effect: Prevents the body from hearing the item

State: "I OBJECT TO THE CONSIDERATION OF THE ITEM."

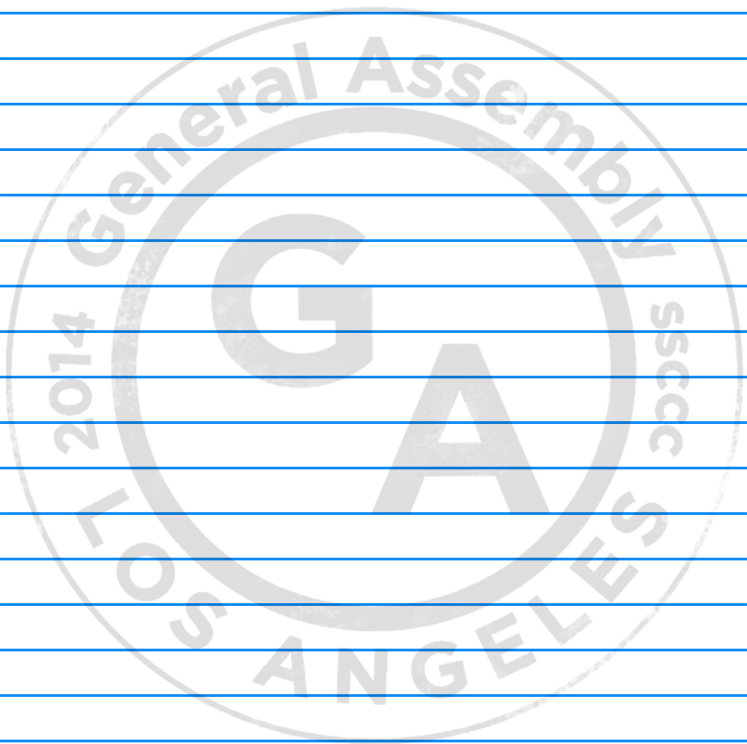
### POSTPONE

Cannot interrupt the floor; must state a time until which an item is postponed to; must be seconded; non-debatable; requires 2/3

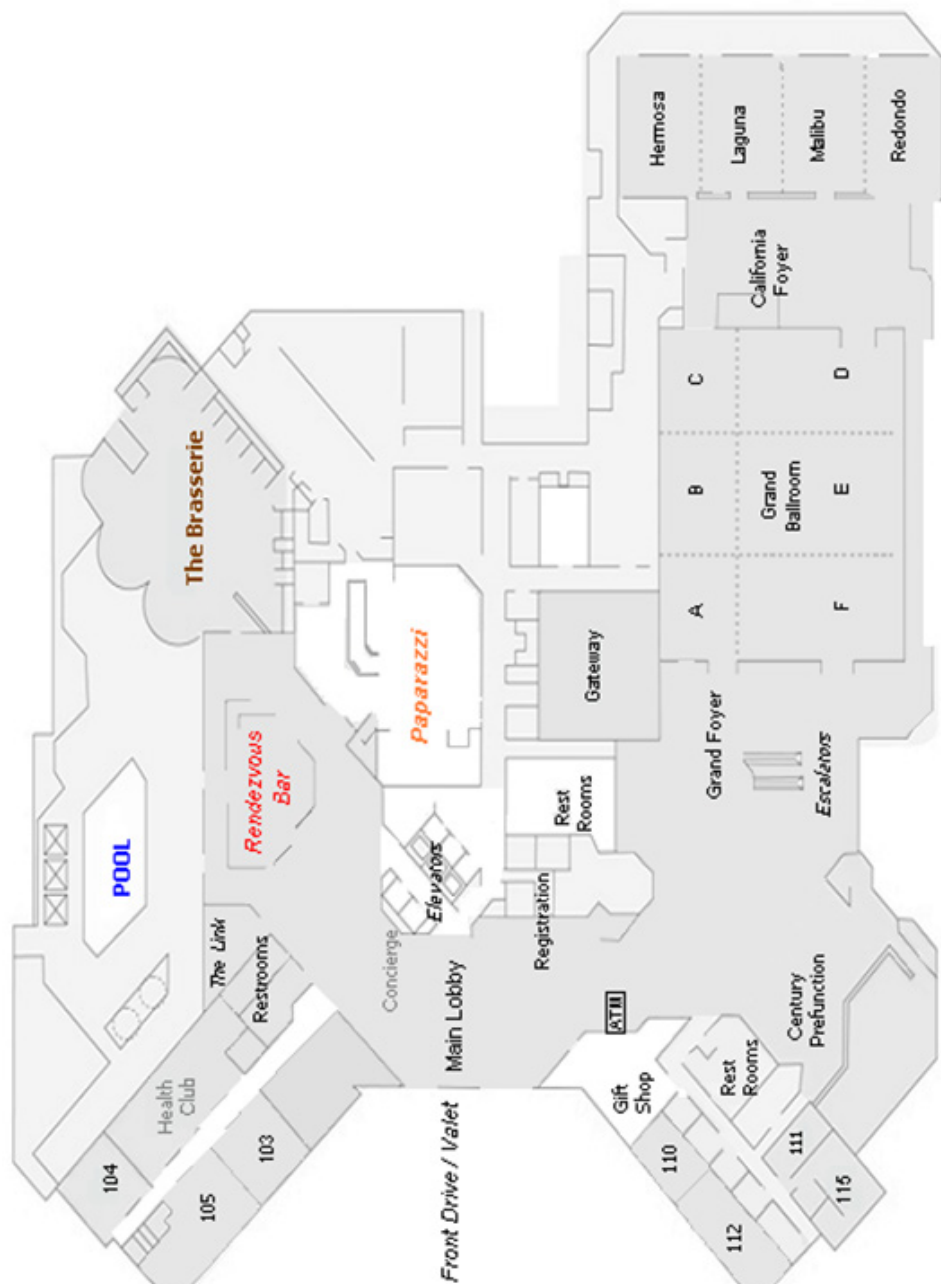
Effect: Postpones an item to either a defined point in time or indefinitely

State: "I MOVE TO POSTPONE THE ITEM..."

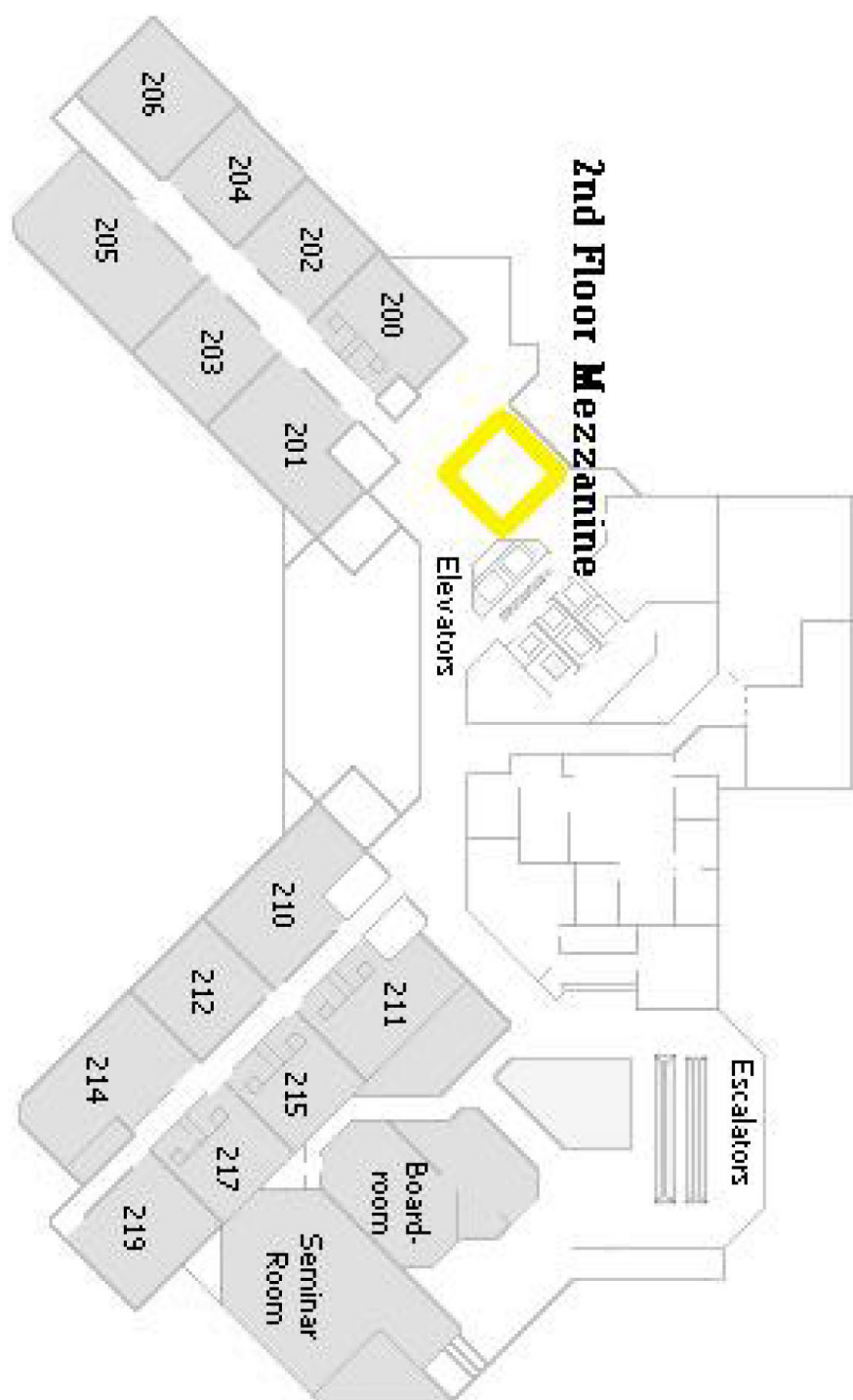

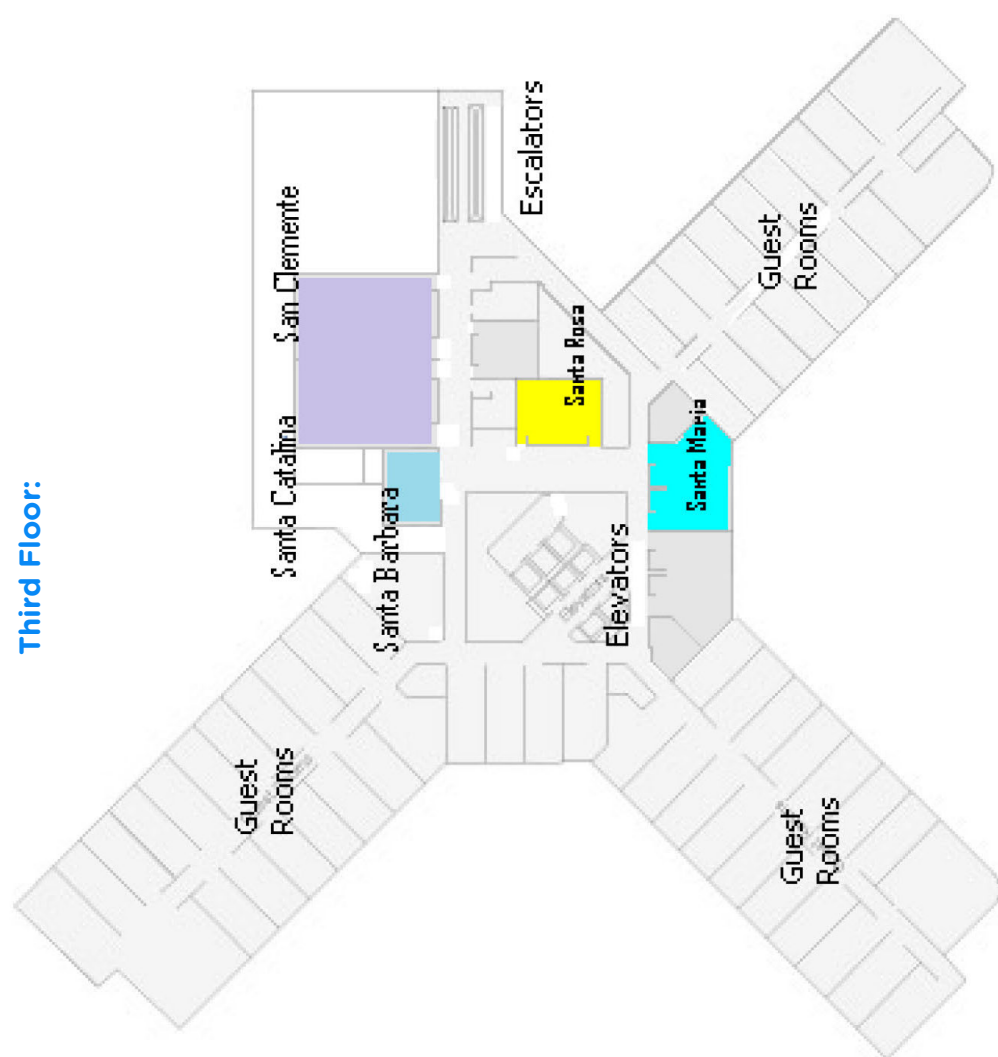

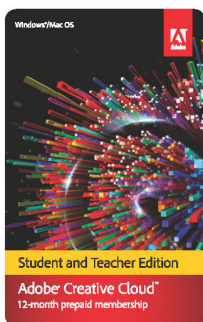


### Third Floor:
